1. How to Enter: From (i) 8:30 am Eastern Time (“ET”) on September 19, 2018 to 12:00 p.m. ET on October 16, 2018, (the “Promotion Period”), you may enter ArtsWave’s Arts x Tech Entry Raffle (the “Raffle”) by visiting the ArtsWave website at ArtsWave.org/ArtsxTech and registering to participate in ArtsWave’s Arts x Tech weekend.

2. Entry Requirements: Upon completion of the registration form and participation in the ArtsWave Arts x Tech weekend, one drawing will be made randomly to give away one Apple Watch 3.

Any attempt by you to obtain more than allowable number of entries by using multiple/different, identities, email addresses, or any other methods, may void your entries and you may be disqualified from the Raffle. If, in Sponsor’s opinion, there is any suspected or actual evidence of tampering with any portion of the Raffle, Sponsor reserves the right at its sole discretion to disqualify any individual who tampers with the entry process and void any entries submitted fraudulently, to modify, suspend, or to terminate the Raffle.

3. Eligibility: This Contest is open only to legal residents of the 50 United States and D.C., who are 18 years of age or older and legal age of majority in applicable jurisdiction as of the Raffle start date. Void where prohibited. 7. Prizes: The entrant whose name is randomly selected shall win the following: an Apple Watch 3. Winner must be present to win or the prize will be forfeited, and a new winner will be selected.

The specifics of all aforementioned elements of the prizes in the Raffle shall be solely determined by Sponsor. All costs, taxes, fees, and expenses associated with any element of the prizes not specifically addressed above are the sole responsibility of the prize winner. Any action or litigation concerning this Agreement shall take place exclusively in the federal or state courts sitting in Hamilton County, Ohio, and you expressly consent to the jurisdiction of and venue in such courts and waive all defenses of lack of jurisdiction and inconvenient forum with respect to such courts. Any and all disputes, claims, and causes of action arising out of or in connection with this Raffle, shall be resolved individually, without resort to any form of class action. You agree to service of process by mail or other method acceptable under

the laws of the State of Ohio. ANY CLAIMS, JUDGMENTS AND/OR AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS ASSOCIATED WITH ENTERING THIS RAFFLE.
