## ArtsWave to Host Free, Outdoor Concert at Miami Whitewater Forest

CINCINNATI (August 19, 2021) – ArtsWave, the region's engine for the arts, announces an afternoon of free, live music Saturday, August 28, from 1 to 5:30 p.m., at Great Parks of Hamilton County's Miami Whitewater Forest (9001 Mt. Hope Rd., Harrison, OH), as part of its free monthly outdoor concert series, Enjoy the Arts @ Parks, presented by Macy's.

Miami Whitewater Forest is set to be awash in music. Satin Smooth Project kicks off the day with their blend of smooth jazz, funk and soul. They'll take you down memory lane until you're dancin' by the lake to some of your favorite songs of the last 40 years. Taifa will keep you moving as they bring a soulful edge to songs you know and love. Topping us off, Just Vince and the Fellas take a break from their usual gig at the Redmoor to treat you to timeless classics of pop, R&B, soul, dance and more.

Enjoy the Arts @ Parks Series, presented by Macy's, is a new, eight-month series programmed during ArtsWave's 2021 Campaign to fund the arts. Each event features performances from a diverse set of arts organizations and independent artists. ArtsWave created the series through partnerships with Great Parks of Hamilton County, the City of Covington (Devou Parks) and Boone County Parks (Boone Woods). The Miami Whitewater Forest concert marks the fourth of the six that will be performed at various Great Parks of Hamilton County locations across the region.

New donors to ArtsWave and those increasing their last gift by 10%+ can receive a free year-long Great Parks of Hamilton County Motor Vehicle Permit, which allows free parking at all Great Parks throughout 2021, as well as other benefits.

That engagement is critical for ArtsWave, which is the largest community arts fund in the nation. Funds from the 2021 Campaign will support 100+ projects and organizations throughout the 15 counties that make up the Cincinnati Region.

## About ArtsWave:

ArtsWave, a nonprofit serving the Greater Cincinnati and Northern Kentucky Region, is the engine for the arts. Its roots stem back to the late 1920s when the Cincinnati Taft family provided initial investment matched by community support. In the late 1940s, it evolved to become the first united arts fund in the nation and in the mid-1970s, the first organization to initiate workplace giving for the arts. ArtsWave continues to innovate while leading, as illustrated by its No. 1 rank nationally in community arts fundraising; coordination of a sector-wide Blueprint for Collective Action; piloting of new technologies to maximize arts engagement; and development of resources for the arts.

Strong funding for the arts has allowed Cincinnati's arts and culture scene to become a national draw and regional asset, creating a wave of economic and community benefits. Each year, ArtsWave supports the work of over 100 arts organizations, school outreach programs, festivals, community centers, neighborhoods and various collaborations through impact-based grants. ArtsWave is projected to raise \$11 million for the arts in 2021, despite the difficult 18-month health and economic crisis that has affected the entire region. ## **About Great Parks of Hamilton County:**

A valid Motor Vehicle Permit is required to enter the parks. Cost for residents of Hamilton County: \$10 annual/\$5 daily; other visitors: \$16 annual/\$8 daily. Otto Armleder Memorial Park and Fernbank Park are cooperative ventures with the City of Cincinnati; a Motor Vehicle Permit is not required. A Motor Vehicle Permit is not required at Great Parks Nature Center at The Summit.
